Warranty Agreement

Light Institutional, Limited Warranty; This Warranty applies only in Victoria Australia to products manufactured or distributed by Xtreme Fitness Australia P/L and or appointed agents, under the Steelflex brand name. The warranty period to the original purchaser is as follows:

3 year Motor, 2 years drive system, 2 years parts, 1 year labour.

Steelflex warrants that the Product you have purchased for light-institutional use from Xtreme Fitness Australia or from an authorized Steelflex reseller is free from defects in materials or workmanship under normal use during the warranty period. Your sales receipt, showing the date of purchase of the Product, is your proof of the date of purchase. This warranty extends only to you, the original purchaser. It is not transferable to anyone who subsequently purchases the Product from you. It excludes expendable parts such as paint and finish. This Warranty becomes VALID ONLY if the Product is assembled / installed according to the instructions / directions included with the Product.

During the warranty period Steelflex will at no additional charge, repair or replace (at Xtreme Fitness Australia PL option) the Product if it becomes defective, malfunctions, or otherwise fails to conform with this Warranty under normal light-institutional, personal, family, or household use. In repairing the product Xtreme Fitness may replace defective parts or, at the option of Xtreme Fitness Australia PL, serviceable used parts that are equivalent to new parts in performance. All exchanged parts and Products replaced under this warranty will become the property of Xtreme Fitness Australia P/L. Xtreme Fitness Australia reserves the right to change manufacturers of any part to cover any existing warranty.

If outside of the Melbourne Metropolitan area (35km) from Melbourne CBD. To obtain warranty service, you must return the Product to Xtreme Fitness Australia P/L in its original container (or equivalent). You must pre-pay any shipping charges, export taxes, customs duties and taxes, or any other charges associated with transportation of the Product. In addition, you are responsible for insuring any Product shipped or returned. You assume the risk of loss during shipment. You must



present Xtreme Fitness Australia P/L with proof-of-purchase documents (including the date of purchase). Any evidence of alteration, erasing or forgery of proof -of-purchase documents will be cause to void this Warranty.

This Warranty does not extend to any Product not purchased from Xtreme Fitness Australia P/L or from an authorized Steelflex reseller. This Warranty does not extend to any Product that has been damaged or rendered defective; (a) as a result of accident, misuse, or abuse; (b) by the use of parts not manufactured or sold by Steelflex; (c) by modification of the Product; (d) as a result of service by anyone other than an authorized Steelflex service agent, or an authorized Steelflex warranty service provider. Should any product submitted for Warranty service be found to be ineligible, an estimate of repair cost will be furnished and the repair will be made if requested by you upon Xtreme Fitness Australia P/L receipt of payment or acceptable arrangement of payment.
