## Warranty Agreement

- 1. This Warranty applies only in the Victoria Australia to products manufactured or distributed by Xtreme Fitness Australia P/L and or appointed agents under the Body-Solid brand name. The warranty period to the original purchaser is lifetime of the original purchaser.
- Xtreme Fitness Australia P/L warrants that the Product you have purchased for non-commercial, personal, family, or household use from Xtreme Fitness Australia P/L or an authorized Body-Solid agent or from an authorized Body-Solid reseller is free from defects in materials or workmanship under normal



- reseller is free from defects in materials or workmanship under normal use during the warranty period.
- 3. Your sales receipt, showing the date of purchase of the Product, is your proof of the date of purchase.
- 4. This warranty extends only to you, the original purchaser. It is not transferable to anyone who subsequently purchases the Product from you.

## Warranty Service

If outside the Melbourne Metropolitan area (35km) from the Melbourne CBD. To obtain warranty service, you must return the Product to Xtreme Fitness Australia P/L in its original container (or equivalent). You must pre-pay any shipping charges, export taxes, customs duties and taxes, or any other charges associated with transportation of the Product. In addition, you are responsible for insuring any Product shipped or returned. You assume the risk of loss during shipment.
