

## **GETRXD AND XEBEX WARRANTY**

## Warranty Agreement

- 1. This Warranty applies only in the Victoria Australia to products manufactured or distributed by Xtreme Fitness Australia P/L and or appointed agents under **the GetRxd and XEBEX** brand name. The warranty period to the original purchaser only.
- Xtreme Fitness Australia P/L warrants that the Product you have purchased for commercial, use from Xtreme Fitness Australia P/L or an authorized GetRxd and XEBEX agent or from an authorized GetRxd and XEBEX reseller is free from defects in materials or workmanship under normal use during the warranty period.
- 3. Your sales receipt, showing the date of purchase of the Product, is your proof of the date of purchase.
- 4. This warranty extends only to you, the original purchaser. It is not transferable to anyone who subsequently purchases the Product from you.
- 5. It excludes expendable parts such as paint and finish.
- 6. This Warranty becomes VALID ONLY if the Product is assembled / installed according to the instructions / directions included with the Product.

## Warranty Service

• If outside the Melbourne Metropolitan area (35km) from the Melbourne CBD. To obtain warranty service, you must return the Product to Xtreme Fitness Australia P/L in its original container (or equivalent). You must pre-pay any shipping charges, export taxes, customs duties and taxes, or any other charges associated with transportation of the Product. In addition, you are responsible for insuring any Product shipped or returned. You assume the risk of loss during shipment. You must present Xtreme Fitness Australia with proof-of-purchase documents (including the date of purchase). Any evidence of alteration, erasing or forgery of proof -of-purchase documents will be cause to void this Warranty.

This Warranty does not extend to any Product not purchased from Xtreme Fitness Australia or from an authorized GetRxd and XEBEX reseller. This Warranty does not extend to any Product that has been damaged or rendered defective; (a) as a result of accident, misuse, or abuse; (b) by the use of parts not manufactured or sold by GetRxd and XEBEX (c) by modification of the Product; (d) as a result of service by anyone other than Xtreme Fitness Australia P/L, or an authorized GetRxd and XEBEX warranty service provider. Should any product submitted for Warranty service be found to be ineligible, an estimate of repair cost will be furnished and the repair will be made if requested by you upon Xtreme Fitness

Australia's receipt of payment or acceptable arrangement of payment.

 EXCEPT AS EXPRESSLY SET FORTH IN THIS WARRANTY Xtreme Fitness Australia P/L and GetRxd and XEBEX MAKES NO OTHER WARRANTIES, EXPRESSED OR IMPLIED INCLUDING ANY IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE. Xtreme Fitness Australia P/L and GetRxd and XEBEX EXPRESSLY DISCLAIMS ALL WARRANTIES NOT STATED IN THIS WARRANTY. ANY IMPLIED WARRANTIES THAT MAY BE IMPOSED BY LAW ARE LIMITED TO THE TERMS OF THIS WARRANTY. NEITHER Xtreme Fitness Australia P/L, GetRxd and XEBEX NOR ANY OF ITS AFFILIATES SHALL BE RESPONSIBLE FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES. SOME STATES DO NOT ALLOW LIMITATIONS ON HOW LONG AN IMPLIED WARRANTY LASTS OR THE EXCLUSION OR LIMITATION OF INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE LIMITATIONS OR EXCLUSION MAY NOT APPLY TO YOU.
